Bullying, harassment, or intimidation means intentional conduct, including verbal, physical, or written conduct, or an intentional electronic communication, that:

- creates a hostile educational environment by substantially interfering with a student's educational benefits, opportunities, or performance, or with a student's physical or psychological well-being
- is motivated by an actual or a perceived personal characteristic including race, national origin, marital status, sex, sexual orientation, gender identity, religion, ancestry, physical attribute, socioeconomic status, familial status, or physical or mental ability or disability
- is threatening or seriously intimidating; and occurs on school property, at a school activity or event, or on a school bus or substantially disrupts the orderly operation of a school.

Electronic communication means a communication transmitted by means of an electronic device, including a telephone, cellular phone, computer, or pager.
